ABOUT THE TRIBUNAL

The Elections Oversight Panel (**Panel**) was established by the IPC to ensure that candidacies and elections for the Governing Board and Athletes' Council comply with the Constitution and relevant Regulations. Further information is available in the Panel's Terms of Reference as published in the Handbook on the IPC website.

ABOUT THE ROLE(S)

The Panel requires three members, ideally from the following backgrounds:

- Legal expertise in particular with regulatory matters and/or with prior experience of tribunals/hearings.
- In-depth knowledge of the Paralympic Movement.
- Good understanding of IPC governance structures and regulations within the Paralympic Movement.

The Panel are responsible for the following:

- Ensure that candidacies and elections for the IPC Governing Board and IPC Athletes' Council comply with the IPC Constitution and regulations.
- Monitor the candidate election campaigns for the election of the IPC Governing Board and IPC Athletes' Council.
- Advise and respond to questions raised by the candidates and/or their nominating body in relation to their rights and obligations.
- Determine whether an infringement of the rules has occurred and subsequently impose any appropriate sanctions.

The term of appointment to the Panel is generally four (4) years, which may be renewed at the end of that term (to a maximum of three (3) terms). The Panel will largely conduct its work online.

This is a voluntary role and as such there is no remuneration. However, expenses are paid in accordance with the IPC's policies. Administrative support is provided by the secretariat of the Panel.

- Ability to consider evidence and give reasoned findings.
- Be able to work cooperatively with a team of people including the Chairperson, other Panel members and the IPC staff liaison.
- Maintain the highest levels of integrity, including maintaining strict impartiality and confidentiality.
- Be positive advocates of the Panel and its work and be committed to ensuring its integrity and credibility.
- Be fluent in written and spoken English.
- Be independent of the IPC. Must not be a candidate for election or have an official position on the board of the nominating body of any of the candidates.
