The International Paralympic Committee (IPC) is seeking appropriately qualified volunteers to join its Medical Expert Advisory Group (MEAG) for the Milano Cortina 2026 Paralympic Winter Games, to be convened as soon as possible in 2025 and ending on 16 March 2026.

# ROLE

As part of the IPC's transitional governance reforms, and during this interim period, the IPC is putting in place a Medical Expert Advisory Group to assist the IPC solely in relation to the Milano Cortina 2026 Paralympic Winter Games (the **MiCo Medical Expert Advisory Group**).

The MiCo Medical Expert Advisory Group will consist of:

- The IPC's external Medical Director, Dr. Wayne Derman, who will act as the chair of the group.
- The Chairperson of the IPC TUE Committee, Dr. Jan Lexell.
- 5 other volunteer members.

The MiCo Medical Expert Advisory Group is appointed by the CEO and will be responsible for assisting and advising the IPC Management Team on medical matters in the lead up to and during the Milano Cortina 2026 Paralympic Winter Games (up to 16 March 2026), including:

- Advising on the planning and delivery of medical services for the Games.
- Assisting and advising the IPC, and the organising committee where requested, on situational management of any public health or acute medical matters affecting the Games (e.g., severe weather, COVID-19 and other infectious outbreaks, severe medical matters and fatalities).
- Participating as needed in the NPC Team Physician meeting, and other meetings as required.
- Supporting the IPC, as needed, in the management of Games-time mental health and safeguarding matters, including services in the Mindzone area(s).
- Attending the Games for the full Games period (~2 to 16 March 2025).
- Where applicable, assisting the injury, illness and mental health surveillance team with data collection from NPC medical staff during Games time.

The MiCo Medical Expert Advisory Group will be managed by the IPC Medical and Scientific Department.

However, it is possible that an in-person meeting may be necessary.

This is a voluntary role as such there is no remuneration. However, travel and accommodation expenses are paid in accordance with the IPC's financial policies.

#### CORE REQUIREMENTS:

- Must be a qualified medical practitioner or allied health professional and/or have significant experience in the field of mental health and safeguarding.
- Knowledge of and/or experience in the Paralympic Movement and Paralympic Games environment especially in the Winter Games setting.
- Experience supporting or advising volunteer-led initiatives or organisations.
- Demonstrated understanding of, or experience working with, IPC members or with Para sport.
- Excellent communication skills in multicultural and global settings.
- Ability to contribute in a timely, confidential, and professional manner.
- An ability to work under sometimes pressured conditions, and to prioritise tasks appropriately and adapt to situational demands.
- Fluency in English (verbal and written).
- Must not be appointed to a role for MiCo with an NPC.
